**Decision**           • Committee approved minutes.

**Discussion**           • Hannah Hale joined the committee as an Athlete member.  
• Legislation adopted at the 2015 USAS convention says that athletes shall make up at least 20% of all committees.

- **Registration Status**

**Discussion**           • As of this date, 203 officials are qualified for PVS reimbursement.  
• Rolled out on-line registration for new officials last week, which allow on-line payment of fees. As of this date, 58 new officials have registered.  
• T. Husson has been recognized with a Life Membership in USA Swimming.

- **Clinics**

**Discussion**           • Invited 14 as New Referees, 8 attended the clinic, 4 deferred to January.  
• Held on-line S&T on 7Oct. Encountered some technical issues during the session. Currently researching cause for problems. Estimated 55 students.  
• S. Edwards distributed clinic attendance counts for the season.  
• Added Starter and S&T clinics for Swim & Rock. Looking for instructors.  
• Level 1 YMCA officials (S&T) transfer, USA Swimming has a reciprocity policy. Need to develop a policy for transfer of Level 2 YMCA officials (Starter/ Referee). T. Husson outlined a possible policy for handling Level 2 transfer. Committee discussed alternatives.

#### Discussion

### • USA-S Convention Recap

#### Discussion

- T. Husson summarized rule changes approved at the USA Swimming convention.
- 170 OQM meets held in the US last year.
- National Meet updates.
- Currently 1,400 athletes have qualified times for Olympic Trials.
- Futures Meets do not count as “national meets” for N3 certification, however the Arena Pro Series meets will count starting this fall.

### • LSC Officials Chairs Quarterly Conference Call – 07Oct2015

#### Discussion

- T. Husson participated in the quarterly call.
- Rules & Regulations Chair reiterated the interpretation that being on the back during the freestyle portion of IM and Medley Relay events is a disqualification.
- USA Swimming is planning to do N2 Admin Official certification.
