Discussion

- General agreement to make staying an official as easy as possible
- Consider changing the required sessions to zero for the 2020 year
- Extend certification expirations by a year

Motion

• Extend certifications expiring in 2020, 2021 or 2022 by one year and keep the total required sessions unchanged (Motion passed)

Clinic requirement for certification - Barb Ship

Discussion

- Clinics are still part of the certification process
- Extend timeframe of certification completion

Motion

 Anyone who attended a clinic in 2019 or 2020 but has not completed their certification requirements be allotted one additional year for completion (Motion passed)

Referee candidate session requirements - Barb Ship

Discussion

 Maintain the same number of starter and CJ sessions as a requirement and look at time-frame of the overall session requirements

Decision

• Eligible candidates will be invited to the next new referee training

PVS session requirement for USA-S official membership fees - Barb Ship

Discussion

- There were very few meets at the beginning of 2020 and there are not likely to be many opportunities for the remainder of the year
- Based on the current number of sessions worked, the number of sessions required so that the cost to PVS would approximately equal the budgeted amount would be four sessions. That assumes that officials do not work any additional sessions this year.
- Put as much of the Officials Committee budget toward membership fees

Motion

Suggest to the PVS Board that the number of required sessions for PVS to pay an
official's USA-S membership dues to be set at four sessions for 2020 (Motion passed)

PVS reimbursement for background checks - Barb Ship

Discussion

- Encourage individuals to wait for background checks unless needed
- Number of sessions currently is both forward and backward, meaning that the official
 must work at least 6 sessions at PVS sanctioned meets (as recorded in OTS) in the 12
 month period beginning 6 months prior to the date of background screening and
 extending to 6 months after the date of screening in order to be eligible for
 reimbursement meaning

Decision

 Recommend to PVS BOD reimbursement after six sessions are worked (no timeframe) going forward for new officials, recertifying officials. Additionally, have additional qualifying period for recertifying officials in the past that would include the 12 months
