# **OFFICIALS TRACKING SYSTEM (OTS)**

USA Swimming continues to improve the Officials Tracking System (OTS). It has come a long way since last October – Meet Referees can now add officials to meets in advance, officials can now see their certifications and meet history. Meet history prior to September 1, 2022, is still lacking some detail. National Certifications and LSC Certifications are available – the information is as of September 1, 2022.

#### **National Certifications**

Applications and updates to National Certifications will continue outside OTS for the immediate future. National Certifications are updated once a month on the National Certification & Evaluation page of the USA Swimming website. All National Certifications expiring 12/31/2022 and 6/30/2023 were extended to 12/31/2023. Requirements for recertification have not changed.

#### **PVS Certifications**

The <u>PVS Officials Roster</u> has the most current certification information for PVS Officials. If your certifications expire 12/31/2023, please plan to attend a PVS clinic in the Fall to recertify. Complete certification and recertification requirements are available on the <u>PVS website</u>.

#### **Meet History**

It is a great time to review your OTS Meet History for the past season. Due to a (now fixed) bug in OTS, it is possible that meets and/or sessions that you officiated during the 2022-2023 season are missing. If you notice errors or omissions, please contact the Meet Referee.

#### **RULES UPDATES**

Recent changes at World Aquatics mean rule changes may come more often than in the past. USA Swimming has created a spot on the <u>USA Swimming website</u> where it will post rule changes after the rulebook has been printed.

# **FALL CLINIC SCHEDULE**

The PVS Fall Officials Clinic schedule will be posted to the <u>PVS website</u> soon. If you need to recertify in 2023 or have been considering certifying in additional positions, please add the necessary clinic to your calendar. Pre-registration is required.

# 2024 USA SWIMMING REGISTRATION – CHANGES COMING

USA Swimming recognizes that 2023 registration produced some challenges and it is working to make 2024 registration easier. Clubs will have the option to bulk renew their members; there will be a one-button renewal option for individuals. If your club opts to bulk renew their non-athletes, your will club will renew your registration for 2024. Your current registration is valid through 12/31/2023, so there is no rush to register for 2024.
