

Competition Committee items requiring action;

1. 2009-2010 PVS Meet Schedule: the following are the proposed dates recommended by the Competition Committee for all of the 09-10 PVS meets. All dates were selected based upon the 08-09 schedule, however it was proposed and approved to move the January Distance and January Open each a week later. There was also a proposal to move the B/BB meet a week later in February, however no one seconded the motion, so the meet remained on its original date.

- October Open; Oct 16-18
- November Open; Nov 6-8
- **January Distance;** proposal to move to 1/9-10, second and passed
- **January Open;** Proposal to move to the 23/24 weekend; second and passed
- February Distance; Feb 14-15
