#### 2023 PVS Winter Competition Committee Meeting January 10, 2023 Video Conference- 7:00 p.m.

- Call to Order The meeting was called to order at 7:00 pm by Age Group Chair, Erik Collins.
- Approval of Fall Competition Committee Meeting (CCM) minutes -
  - Motion to approve the minutes from the Fall CCM, seconded and approved.
- USA Swimming Advisor, Beth Winkowski was in attendance, she reported:
  - Information from USA Swimming will be dispersed, as it is received. All coaches were reminded that they can reach out to Beth anytime with questions at bwinkowski@usaswimming.org
- Board Reports:
  - Athletes No report submitted
  - Admin Chair No report submitted
  - Senior Chair Evan Stiles reported:
    - All Athlete Travel Assistance applications from US Open and Winter Junior Nationals, have been processed and sent to the Treasurer. Checks will be distributed
  - Age Group Chair Erik Collins reported:
    - He has been working with Henry Tollefson, LC Zone Team Manager, on preparing for the 2023 Summer LC Zone Trip. He thanked Henry for his work and together they will continue to plan for Summer AG Zones in Richmond.
    - Qualifying times for the SC 14&U Championships have been posted. Meet Announcements are currently being reviewed by the Technical Committee
  - Safe Sport Chair No report submitted
  - DEI Chair No report submitted
    - A question was asked about information on the DEI Grant Program. She was directed to reach out to the DEI Chair for more information.
  - Coaches Reps Trish Buswell reported:
    - Trish Buswell reported: Elections for the Junior Coaches Representative will take place towards the end of March. If anyone is interested in running for the position, please reach out to Trish or Aaron.
    - Aaron Dean reported:
      - He plans to do some research for alternatives for the VSI Surcharge, that PVS clubs pay when a meet is held within Virginia Swimming boundaries.
      - He will also be looking at the Swimmer Transfer process from team to team in PVS, to ensure that it is a smooth and respectable process for all parties involved.
  - Additional Board Reports: Tim Husson reported:
    - The PVS Athlete Representative have been working with Jessica Fry on applications for the Athlete Leadership Retreat in Maine in June. This will be an opportunity for PVS swimmers who are interested in leadership positions to join other athletes in the Eastern Zone. More information and the application will be available soon. The selections will be leadership based, not performance based.

It was noted that it is anticipated for Athletes to participate in this retreat they will be expected to join a PVS Committee.

- PVS Meets Update on PVS Meets, Tim Husson reported
  - The Distance meet held this past weekend at St. James was well attended and ran smoothly. The St. James is a great facility to host this meet. The online check-in and seeding process worked well. The meet was a success and thank you to everyone who helped.
  - The January Open is coming up on 20-21 January. All entries have been submitted and the balancing and timeline updates are underway. There are some changes that will be necessary to fit all swimmers on deck and all swims within the timelines.
    - Tim made several suggestions as to how best to ease the timelines on Sunday. There was a brief discussion regarding the amount of time and structure for warm up. All information regarding the January Open will be sent out and posted in the coming days.
    - Tim did note that the January Open numbers are similar to our numbers from 2019.
    - There was a brief discussion on the need for more officials and possibly looking at the process of how Officials move through the ranks in PVS.
      - PVS has certified quite a few new Officials already this season. The Official's Committee is working hard to rebuild our pool of volunteer Officials.
    - PVS is still looking for several clubs to host the PVS LC Open meets this June.
      Please contact Terri if your club is interested.
  - Governance Committee Paris Jacobs reported on some necessary housekeeping items regarding the Policies and Procedures.
    - Outstanding Athlete Voting Paris explained that the wording in P&P was out of date and unclear as to who can vote for the PVS Outstanding Athlete Award. She submitted a document with the suggested changes, which will help more clearly define the voting process and who is eligible to vote. Paris shared a document showing the proposed change in wording. She explained that the procedure can be further discussed in the spring, but for now she wanted to focus on the wording of the policy.
      - Motion to accept the changes to P&P regarding the voting policy for PVS
        Outstanding Athlete, seconded and approved.
    - Athlete Travel Assistance Paris commented that PVS is one of the few LSC that require an application form be submitted in order to receive travel assistance for athletes. The process currently in place is time consuming and cumbersome for coaches who must complete the forms. The Governance Committee is looking to see if there is a need and a way to simplify the process.
      - Evan Stiles, Senior Chair, explained that currently clubs have to fill out a 2-part form, to indicate the swimmer participated in the Meet and that the athlete also meets the qualifications set forth by this body. Once the forms are received by the Senior Chair, all information is reviewed, confirmed and approved, then sent to the Treasurer for payment to the clubs.
        - It was suggested to form a task force to review the application process and see if there is a simpler way. Evan and Erik will work together to form this group and look at the process. If anyone is interested in helping with this process, please contact them.

- Club Competition Schedule Paris is concerned that we are planning the Club Competition Schedule in January for the following season is premature and that assumptions are being made about the calendar based upon historical data and not actual dates. She suggests we continue to collect all Club meet dates in January, confirm in February once all school schedules are released and then finalize the schedule with the Board of Directors vote in March.
  - There was a brief discussion and the majority felt the current process should stay in place for now. We can revisit at the Spring Competition Committee Meeting if warranted.
- New Registration- Swims3.0- PVS Registrar, Kelly Rowell reported:
  - Clubs do not need to send duplicate records to Kelly. She has access to the report with the long list of duplicate records and will be working through this list one club at a time.
  - Number of registrations The attached document was shared to show our current registration numbers.
    - There has been a steady stream of new officials this year.
  - All clubs have been sent an email with the coaches who will expire by the end of the year. There are still some known issues with Athlete Protection Training (APT) and Coaches Advantage Training (CAT). If any coach has completed the training but is not reflected in SWIMS, send Kelly an email with the date of APT/CAT completion and she will be able to get it updated.
  - Team Unify is continuing to have issues communicating with SWIMS 3.0. Both entities are working on this and it is reported to just be "growing pains." It was noted that if there is a swimmer's time that is loaded from a meet, but then disappears from SWIMS, that it is still in Team Unify and therefore can still be retrieved.
  - It was asked when Clubs will be able to pull a times report from SWIMS, a task currently unavailable. It is currently not known when the reporting aspects of SWIMS will be working.
  - There are meets coming up with Qualifying Times. Since the times recon is not currently available, we will work on a process to verify times for the PVS Spring Championship meets.
- Officials Official's Chair, Kelly Rowell reported:
  - PVS has had a steady stream of newly certified officials this season. She is doing the best she can to keep track of the rosters through spreadsheets, since we cannot pull information out of SWIMS.
  - It was asked if PVS planning on adhering to the officials/registered swimmer ratio for this year policy for this year?
    - If we can accurately produce the numbers of both athletes and officials, then we will keep the policy in place. We will revisit this during the year.
- Club meet Bids for 2023-2024 schedule was presented and reviewed
  - Motion to endorse the 2023-2023 PVS and Club meet schedule as presented, seconded and approved.
- PVS Championship meet preview
  - Qualifying times have been posted for the SC 14&U, Junior and Senior Champs.
  - Coaches are expected to be entering athletes with accurate and verifiable times. PVS will do the best we can to further verify times accurately, if possible.
    - Karyn McCannon, the Meet Entry Coordinator, suggested that each club submit a Proof of Times report with their entry files. This information will need to be added to the meet announcement.

- For HS Observed Meets, SWIMS will match with accurate First Name, Last Name and Birthdate. ID numbers are not needed.
- Summer Zones Henry Tollefson, Zone Team Manager, reported:
  - Buses and Hotels are reserved for up to 200 athletes. He is still working on apparel. If you are interested in being a Zone Team coach, please contact Age Group Chair, Erik Collins.
- LC Championship Qualifying Times -
  - The QT will be based on the desired size of the meet and timelines, using historical data. Last summer's LC meets will be used as the basis.
  - The goal will be to have Qualifying Times published by the first week of April.
- 2024 Budget The Board will begin working on the budget cycle for the 2023-2024 fiscal year at the next meeting. Are there any new programs/items that anyone wants to add to the budget? If there is anything, please send to Evan, Erik, Trish, Aaron so they can be brought to the Board.
  - There was a question about Athlete Travel Assistance and the budget
    - The Senior Chair yearly recommends the budgeted amount for each meet that PVS provides reimbursement for. In recent years, we have not exceeded the budgeted amount. We have good historical data on which to base these budget amounts. We do not foresee having any issues being able to fund all athletes who request assistance. If ever we were to go over, there is confidence that the Board will approve the additional funding.
  - Any new/old business What is the deadline for budget submissions?
    The Board will finalize the budget at the March Board Meeting.
- The 2023 Spring CCM date (BOD meeting is Tuesday, May 16) Spring CCM, Tuesday, May 23.
- The meeting was adjourned at 9:01 PM.
