

REPORT OF PVS NOMINATING COMMITTEE

APRIL 18, 2011

A Nominating Committee consisting of John Hirschmann, Linda Klopfenstein and Jack Neill was established by the PVS Board of Directors at its March 2011 meeting. A notice was posted to the PVS website in February (see below.). It addressed the Board of Director positions to be elected by the House this year.
