The Officials Committee is authorized and obligated to recruit, train, test, certify, evaluate, retest, recertify, and supervise officials for PVS.

The Officials Committee is responsible for staffing of the two Senior Championship meets, the Junior Olympic meet, and any other PVS sponsored meet in which participating officials may obtain USA Swimming National Certification.

#### **Training, Certification, Re-Certification**

The PVS Officials' Corps is slowly rebuilding. The PVS Officials Committee has supported virtual clinics since the beginning of the pandemic, including the following clinics from April 1, 2022 – March 31, 2023:

6 Stroke & Turn Clinics; 328 attendees

4 Administrative Official Clinics; 35 attendees

4 Chief Judge Clinics; 44 attendees

1 New Referee Clinic; 4 attendees

5 Starter Clinics; 79 attendees

2 Referee Clinics; 44 attendees
