Discussion

- Subcommittee recommends clarifying the number of sessions to be an apprentice and the session number for an evaluation
- Allow a deck mentor to be any S&T certified official that has completed 6 or more sessions since certification

Meet referee requirements to be the meet referee for a PVS club hosted meet - Barb Ship Motion

- Ask the board to amend the P&P (policies and procedures) to allow the meet referee for LSC club meets to be a currently certified meet referee by an LSC or who served as a meet referee at an LSC championship or higher level meet. - BS Second - CJ
- Motion passed

Discussion

- Subcommittee recommends making the 1-year temporary allowance for the meet referee qualification permanent
- Make the provision more precise and request a P&P update

Creation of a new subcommittee entitled "Official Recruitment and Retention" - Barb Ship Discussion

- Create a new subcommittee to develop "best practices" to recruit officials (e.g. financial incentives, etc.)
- Work to develop official chairs for clubs and their role
- Work with training subcommittee to develop optimal clinic schedule and resources to make it easy for officials to certify/recertify.
- Would need an Officials Committee member to chair the subcommittee
