Thank you to the Local Swim Committee (LSC) Officials Chairs who made it a priority to send an official to Denver to learn about mentoring. The underlying theme of the training sessions was how a mentor can have a positive impact on officials when the evaluation and mentoring experience is displayed in a positive and constructive manner. The other important outcome from Summit was the outcome of the legislative actions approved by the USA Swimming House of Delegates. Pinnacle Award Winner: Bob Vincent

Congratulations to this year's Pinnacle Award winner, Bob Vincent!

Bob has served as an official since 2003 and as a board member, board president and ex-officio, interim CEO for USA Swimming, making a difference in the sport from grassroots to the highest levels. Bob has obviously shown incredible servitude to not just the athletes and officials, but the well-being of the organization as a whole.

As an official, Bob serves at the LSC and national levels. Over the last 12 months, Bob has served at 59 LSC sessions as a stroke and turn official, deck referee, meet referee, and as a national evaluator to share his expertise with others. Even as a board member and as interim CEO, Bob continued to offer his skills as an official in a less-prominent, yet still supportive role on the national deck. This past summer, Bob served in the shadows as a head timer at the Toyota National Championships in Indianapolis. Bob tackled all of this while volunteering as a board member and as interim CEO. He embodies the heart of servitude from the developmental age group meets to team selection meets with humility. Bob quietly leads by example. We could not be more proud than to have him in the

ranks of the USA Swimming officials.

The Pinnacle Award, formerly the Kenneth J. Pettigrew Award, is the highest honor given annually to an official whose robust volunteer service spans decades. Recipients of this award have made significant contributions at both the LSC and national levels and exhibit attributes of servant-leadership through work in governance and the highest officiating positions. Selected by the National Officials Committee, the Pinnacle Award is presented each year at the USA Swimming Annual Summit.

- As a part of your 2026 membership, you may request (without additional costs) one **2026 USA Swimming Rulebook**. Use this [order form](#) to request either the regular-size rulebook or the mini-rulebook. You will need your USA Swimming ID number to complete the form. The order form must be completed no later than Monday, December 1, 2025. After this date, the rulebook will need to be purchased through SwimOutlet.
 - **National Meets:** Applications to officiate at national meets are generally posted six months (~180 days) prior to the meet start date. Applications typically close four months (~120 days) prior to the meet start date, but applications may close earlier if a sufficient number of applications have been received.
 - **Toyota U.S. Open:** December 3-6, 2025, in Austin, Texas - MR: Mike Dilli. Applications are now closed.
 - **Speedo Winter Junior Championships:** December 10-13, 2025. Applications are now closed.

 - **TYR Pro Swim Series:** Officials may apply to each of the first three meets in the TYR Pro Swim series, but depending upon the application pool, will be selected to serve at only one of them.

The Officials' Excellence Award:

- National recognition for outstanding officials for LSC contribution
- Anyone can submit, although we will ask the LSC Officials' Chair or LSC General Chair for input
- The nominee must be an active member of USA Swimming with current registration
- There are six awards each year, one each in odd-numbered months
- Nominations close around April
- Nominations are held for two cycles (24 months) unless selected
- The National Officials Committee votes in May for the July through next May period (1 cycle)

Hopefully, your LSC OC committee is actively looking for ways to acknowledge officials and appreciate their service at the local level. This award is just a way to further acknowledge those deserving higher recognition. The link for the nomination form is [here](#).
